Türkiye's January Exports Reached USD 20.3 Billion

Despite geopolitical tensions, protectionist measures, and competitiveness challenges in labor-intensive sectors, exports over the last 12 months reached USD 272.5 billion.



Exports from Türkiye fell by 3.9 percent year-on-year in January due to calendar effects, amounting to \$20.3 billion, while annualized exports rose 3.7 percent to \$272.5 billion, Trade Minister Prof. Dr. Ömer Bolat announced. Türkiye's exports in 2025 increased 4.4 percent from the previous year to \$273.4 billion, while the government's medium-term program sets the country's export target for 2026 at \$282 billion.

World Trade Remains Resilient Despite Disruptions: WTO Chief

Ngozi Okonjo-Iweala says 72% of world trade still done under terms of the global body



Global trade remains resilient despite many disruptions and protectionism, as some 72% of world trade is still done under World Trade Organization (WTO) terms, the body's director-general told the press. Ngozi Okonjo-Iweala, speaking on the sidelines of the 56th World Economic Forum (WEF) held in Davos, Switzerland, said the disruptions could be used as an opportunity to make reforms.

The global trade in goods is expected to grow 2.4% in 2025, falling 0.5% in 2026 due to tariff-induced uncertainties and trade policies, according to the WTO's latest analysis.

Türkiye, UK Sign New Agreements as Both Eye \$40B Trade Target

'We will continue to maintain and strengthen our multifaceted cooperation with the United Kingdom in trade and investment,' says Turkish Trade Minister Prof. Dr. Ömer Bolat



Eyeing a \$40 billion trade target, Türkiye and the UK signed a new Joint Economic and Trade Committee (JETCO) Action Plan containing 16 concrete measures, alongside a mutual recognition agreement, during high-level talks in London. The agreements were signed as part of the 8th term meeting of the Türkiye-UK JETCO, held during a visit to London by Turkish Trade Minister Prof. Dr. Ömer Bolat.


Bolat met Peter Kyle, the UK secretary of state for business and trade, where discussions focused on bilateral trade and economic cooperation, as well as new trade and investment opportunities based on what he described as mutual trust and a win-win approach. According to Bolat, the JETCO meeting in London resulted not only in the signing of the JETCO Protocol but also in agreements aimed at deepening bilateral cooperation. He also said significant progress had been made in negotiations to modernize the free trade agreement between the two countries. “I wholeheartedly believe that this productive meeting and the agreements signed will carry the Türkiye–UK economic partnership forward with renewed dynamism,” Bolat said. “We will continue our efforts to build a strong future based on constructive dialogue and strategic partnership.”

The existing UK–Türkiye Free Trade Agreement, which came into force in 2021, has added momentum to bilateral trade, with trade between the two countries up by more than \$5 billion over the past four years. Bilateral trade rose by \$1.8 billion in the past year alone, reaching \$24 billion. Both countries aim to reach trade targets of \$30 billion in the short term and \$40 billion in the medium term.

Türkiye to Deepen Cooperation with Nigeria in Industry, Trade, Investment and Production

Joint declaration on establishment of Joint Economic and Trade Committee signed to strengthen institutional economic cooperation



Türkiye will deepen cooperation with Nigeria in industry, trade, investment and production, Turkish Trade Minister Prof. Dr. Ömer Bolat said. Bolat made the remarks after he and Industry and Technology Minister Mehmet Fatih Kacır met with Nigeria's Minister of State for Industry, Trade and Investment, John Owan Enoh. The meeting was held under Turkish President Recep Tayyip Erdoğan's chairmanship.

Bolat said that Türkiye and Nigeria signed a joint declaration on the establishment of a Joint Economic and Trade Committee (JETCO) to strengthen institutional economic cooperation between the two countries, along with a Memorandum of Understanding on Halal Quality Infrastructure. “We believe that these steps will create new opportunities for the business communities of both countries,” said Bolat. “In line with the \$5 billion trade volume target set by our presidents, we will resolutely continue our efforts to diversify trade, increase investments, and strengthen ties between our private sectors,” he added. “Türkiye will continue its relations with Nigeria based on trust (and) a long-term and strategic partnership approach,” Bolat said.

Tinubu pledged to deepen cooperation with Türkiye on security and trade, citing shared efforts to combat instability and promote economic growth. Nine agreements were signed between Türkiye and Nigeria in the presence of Presidents Erdoğan and Tinubu following bilateral and delegation-level talks in Ankara. Covering a wide range of sectors, the agreements include cooperation on military training, diaspora policy, media and communication, higher education, halal accreditation, diplomatic training, and social and women's affairs. Bilateral trade volume between the two countries reached \$688.4 million in the first 11 months of 2025. When energy trade is included, Nigeria became Türkiye's largest trading partner in sub-Saharan Africa in 2025.

Turkish firms have long operated in Nigeria's construction, energy, textile and manufacturing sectors, exporting products such as iron, steel, machinery and food while importing crude oil and agricultural goods. More than 50 Turkish-owned companies operate in Nigeria, with total investments valued at around \$400 million. In recent years, the number of projects undertaken by Turkish contractors has increased significantly, with the total value nearing \$3 billion. In line with Ankara's support for Abuja's counterterrorism efforts, cooperation in military affairs, security and the defense industry continues to strengthen steadily.

Turkic World Will Leave Its Mark on This Century: President Erdoğan

Türkiye tripled bilateral trade with Uzbekistan over past decade, says Recep Tayyip Erdoğan



Turkish President Recep Tayyip Erdoğan said that he is confident that Turkic world will leave its mark on this century. "As long as we stand heart to heart, God willing, we are confident we will leave the Turkish world's mark on this century," said Erdoğan, speaking at a joint press conference with his Uzbek counterpart Shavkat Mirziyoyev in Ankara.

Erdoğan said that over the past decade, Türkiye tripled bilateral trade with Uzbekistan. "I believe we will soon reach our new \$5 billion target," he added. With investments exceeding \$5 billion, Turkish companies already rank among the top three investors in Uzbekistan, Erdoğan said, expressing hope to see even better levels. He said they have not only strengthened solidarity between Türkiye and Uzbekistan but elevated it to the level of a comprehensive strategic partnership, and the agreements exchanged set the roadmap for the period ahead. The Turkish president said institutions of both countries are working together to achieve all shared political, economic, cultural, humanitarian and regional goals.


Erdoğan and Mirziyoyev signed the Joint Declaration of the 4th Meeting of the Türkiye-Uzbekistan High-Level Strategic Cooperation Council and the Decision on Cooperation Mechanisms for Comprehensive Strategic Partnership Relations between Türkiye and Uzbekistan. Other agreements covered cooperation in health and education; economic and financial collaboration; trade, investment, free zones and special economic zones; mining and energy; international transport corridors; cultural cooperation for 2026–2027; higher education and light industry development; and enhanced coordination between transport, culture, trade, finance and energy authorities.

Despite Steady Monthly Decreases in Late 2025, The FAO Food Price Index Annual Average Tops 2024

The FAO Food Price Index (FFPI) averaged 124.3 points in December 2025, down 0.8 points (0.6 percent) from November, as declines in the price indices for dairy products, meat and vegetable oils more than offset increases in cereals and sugar. The index stood 3.0 points (2.3 percent) below its level one year ago and as much as 35.9 points (22.4 percent) below the peak reached in March 2022. For the year 2025, the index averaged 127.2 points, 5.2 points (4.3 percent) higher than the 2024 average.



The FAO Cereal Price Index averaged 107.3 points in December, up 1.8 points (1.7 percent) from November. Renewed concerns over Black Sea export flows lent support to international wheat prices; however, markets remained pressured down by ample supplies, with confirmation of large crops in Argentina and Australia reinforcing the downward trend. By contrast, world maize markets were boosted by robust export demand and strong domestic ethanol production in both Brazil and the United States of America, while sorghum prices rose in tandem with maize despite a slow pace of sales to China, the world's major importer of sorghum. The FAO All Rice Price Index rose by 4.3 percent, as prices increased across all rice market segments due to a combination of reduced harvest pressure, improved demand, and supportive policy measures. For the whole of 2025, the FAO Cereal Price Index stood at 107.9 points, down 5.6 points (4.9 percent) from 2024 and marking the lowest annual average since 2020. The FAO All Rice Price Index averaged 103.5 points in 2025, down 35.2 percent from 2024, reflecting downward pressure on rice quotations from ample exportable availabilities, intense competition among exporters, and reduced purchases by some importing countries in Asia.

The FAO Vegetable Oil Price Index averaged 164.6 points in December, down 0.4 points (0.2 percent) from November and marking a six-month low. The decline reflected lower world prices of soy, rapeseed and sunflower oils, which more than offset higher palm oil quotations. Global soy oil prices

declined on ample export supplies from the Americas, while larger rapeseed outputs in Australia and Canada exerted downward pressure on rapeseed markets. For sunflower oil, sluggish global import demand due to weakening price competitiveness contributed to price contractions for the second consecutive month in December. By contrast, international palm oil prices edged up slightly, largely underpinned by prospective seasonal production slowdowns in Southeast Asia, outweighing the impact of higher-than-expected outputs and inventories in Malaysia in late 2025. For the year 2025, the FAO Vegetable Oil Price Index averaged 161.6 points, up 23.6 points (17.1 percent) year-on-year and marking a three-year high amid tight global supplies.

The **FAO Meat Price Index** averaged 123.6 points in December, down 1.7 points (1.3 percent) from its revised November value, but still 4.1 points (3.4 percent) above its level a year ago. Prices declined across all meat categories, with those of bovine and poultry meats falling the most. Lower world bovine meat prices reflected weaker quotations in Australia, where seasonally dry conditions prompted herd destocking, increasing cattle availability for slaughter and exerting downward pressure on prices. International poultry meat quotations declined, as ample exportable supplies outweighed global import demand. Ovine meat prices eased marginally amid larger seasonal supplies entering the market, despite continued solid global import demand. Pig meat prices decreased slightly, led by weaker quotations in the European Union amid subdued global demand. For 2025 as a whole, the FAO Meat Price Index averaged 123.2 points, up 6.0 points (5.1 percent) from 2024, supported by firm global import demand and heightened market uncertainty linked to animal disease outbreaks and geopolitical tensions. World bovine and ovine meat prices were up sharply year on year, on robust import demand and limited export availabilities. By contrast, pig meat prices declined, driven by weaker global import demand, while poultry meat prices edged lower due to abundant supplies.

The **FAO Dairy Price Index** declined by 5.9 points (4.4 percent) in December. Butter prices fell sharply, driven by seasonally higher cream availability in Europe and stock accumulation following strong production earlier in the year. Whole milk powder (WMP) prices also declined, reflecting peak seasonal milk output in Oceania and subdued buying interest from major importing regions. By contrast, skim milk powder (SMP) and cheese prices eased more moderately. SMP prices edged down amid ample export availability and stable market fundamentals, while cheese prices declined overall. Well supplied markets and slower export demand in Europe outweighed firmer cheese prices in New Zealand, where peak milk supplies are mainly absorbed by products with greater processing flexibility, notably butter and milk powders. Despite the recent declines, the FAO Dairy Price Index averaged 146.9 points in 2025, 13.2 percent above the 2024 average, reflecting strong price increases during the first half of the year. The annual rise was driven primarily by cheese, WMP and butter, underpinned by strong global import demand and limited exportable supplies earlier in the year, while SMP prices increased only marginally, reflecting ample availability and comparatively subdued demand growth.

The **FAO Sugar Price Index** averaged 90.7 points in December, up 2.1 points (2.4 percent) from November after three consecutive monthly declines, but it remained 28.6 points (24.0 percent) below its level a year ago. The increase in December was mainly driven by a sharp drop in sugar production in Brazil's key southern growing regions, reflecting lower sugarcane crushing and a reduced use of sugarcane for sugar production. However, expectations of ample global sugar supplies in the current season, supported by good harvest progress and favourable production prospects in India, limited the upward pressure on world prices. For the entire 2025, the FAO Sugar Price Index averaged 104.3 points, down 21.4 points (17.0 percent) from 2024 and marking the lowest annual value since 2020, amid ample export availabilities.

Türkiye to Continue to Assess Joint Steps with Malaysia in Defense: President

Ankara gives importance to its cooperation with regional countries, ASEAN, says Erdoğan



Türkiye will continue to assess the joint steps it can take with Malaysia in the defense industry field, "guided by the win-win principle," President Recep Tayyip Erdoğan said. Erdoğan's remarks came during a joint news conference with Malaysian Prime Minister Anwar Ibrahim.

Noting his visit to Kuala Lumpur in February last year, where both parties agreed to establish a high-level cooperation council between the two countries, Erdoğan said that the first meeting was held. Stating that they had just signed agreements strengthening the contractual foundation of bilateral relations, Erdoğan said that Malaysia is Türkiye's largest trading partner in the ASEAN region. Pointing out that a free trade agreement already exists between Türkiye and Malaysia, Erdoğan noted that during his visit to Kuala Lumpur, they had announced a trade volume target of \$10 billion, adding that he sincerely believes this goal can be reached in a balanced and sustainable manner through joint efforts. He also expressed his desire for Malaysia to increase its investment in Türkiye. "Likewise, we wish to bring renewed momentum to the investment relations between our countries and encourage Malaysia to increase its investments in our country," he further said.

The meeting also addressed the human dimension between the two nations, including education and culture, which "will strengthen the ties" between the two nations, Erdoğan said. He noted that the global issues were also discussed, adding that Ankara and Kuala Lumpur are sharing similar views on those issues. "Especially, we will continue to closely follow Gaza," Erdoğan said. Türkiye gives importance to its cooperation with regional countries and ASEAN under Ankara's Asia Anew Initiative, which was launched in 2019, the President also said.

A joint declaration on the establishment of the high-level strategic cooperation council was signed, along with the minutes of the first joint committee meeting on cooperation in higher education, and a memorandum of understanding between the Investment and Finance Office of Türkiye and the Malaysian Investment Development Authority. The Export Credit Bank of Türkiye and the Export-Import Bank of Malaysia also signed a memorandum of understanding. Economic and social research cooperation between the Foundation for Political, Economic and Social Research (SETA) and the Malaysian Institute of Strategic and International Studies was signed. DESAN Shipyards and the Malaysian Home Affairs Ministry signed a letter of acceptance for the procurement of a multi-purpose mission vessel. Also, a memorandum of understanding on cooperation in information and communication technologies between Türkiye's Information and Communications Technologies Authority and the Malaysian Communications and Multimedia Commission was signed.

Türkiye, Nigeria Sign Deal for Cooperation in Media, Communication

Memorandum aims at exchange of information and experience, organization of seminars, training programs



Türkiye and Nigeria signed a memorandum of understanding for cooperation in the field of media and communication. The agreement was signed in the presence of Türkiye's President Recep Tayyip Erdogan and his Nigerian Head of State Bola Ahmed Tinubu following one-on-one and interdelegational talks in the Turkish capital, Ankara.

The memorandum provides for the exchange of information and experience, the sharing of best practices, support for mutually beneficial initiatives and projects, and the organization of meetings, seminars, workshops, training programs, and conferences. Joint efforts to increase reciprocal visits between officials and experts in the fields of media, communication, and broadcasting are also envisaged under the agreement. The memorandum will remain in force for three years. Türkiye, Nigeria strengthen strategic partnership with 9 key agreements. Nine agreements were signed between Türkiye and Nigeria in the presence of President Erdogan and Tinubu following bilateral and delegation-level talks. Covering a wide range of sectors, the agreements include cooperation on military training, diaspora policy, media and communication, higher education, halal accreditation, diplomatic training, and social and women's affairs.

Somalia's federal Cabinet approved the deal with Türkiye on maritime cooperation, at its regular meeting. The government is reportedly taking urgent measures to mitigate the effects of the ongoing drought and its impact on the country's water and food supplies.

The new deal covers maritime trade developments, ship traffic improvements, port service modernization, mutual recognition of seafaring certificates of competency, technical cooperation and know-how sharing, ensuring equality in port services, and the facilitation of commercial activities. The Türkiye-Somalia cooperation developed in a multidimensional way since 2011, especially in the economy, education, health, infrastructure, and development.

Türkiye's Traditional Weaving Heritage Showcased at Council of Europe

'Türkiye Weaving Atlas' exhibition highlights sustainable craftsmanship and cultural memory



Türkiye's rich tradition of regional weaving will be showcased in Europe as the "Türkiye Weaving Atlas - Memory of Fabric" exhibition opens at the Council of Europe in Strasbourg. The exhibition brings together Türkiye's diverse weaving heritage for the first time in a single showcase, highlighting centuries of craftsmanship and cultural memory.

Organized under the auspices of Turkish first lady Emine Erdoğan, the exhibition is hosted by the Turkish Delegation during the winter session of the Parliamentary Assembly of the Council of Europe. The display features centuries-old weaving knowledge from all seven regions of Türkiye, offering visitors insight into the historical, social and aesthetic dimensions of traditional textiles. All textiles on display are produced using natural fibers and locally sourced materials through environmentally respectful methods. Traditional weaving is recognized as a zero-waste practice carried out without industrial processes.

The works presented highlight weaving as a vessel of memory, identity and culture, while reflecting the Council of Europe's commitment to heritage preservation, rural development and sustainable craftsmanship.
